Eduardo Sanchez, MD, MPH, FAAFP serves as Chief Medical Officer for Prevention for the American Heart Association (AHA). He brings an interest and experience in prevention and population health to AHA. He

served as Deputy Chief Medical Officer for the AHA from April 2013 through 2014. Prior to joining AHA, he served as Vice President and CMO for Blue Cross and Blue Shield of Texas. Dr. Sanchez led the Institute for Health Policy at the University of Texas, School of Public Health as director from 2006 to 2008. From 2001 to 2006, he served as Texas' state health officer, Commissioner of the Texas Department of State Health Services from 2004 to 2006 and the Texas Department of Health from 2001 to 2004. And he served as the local public health officer in Austin-Travis County from 1994 to 1998.

Dr. Sanchez currently serves as Chair of the National Commission on Prevention Priorities and the Texas Public Health Coalition. From 2008 to 2012, he served as chair of the Advisory Committee to the Director of the Centers for Disease Control and Prevention (CDC). He serves on the Institute of Medicine's Roundtable on Obesity Solutions and on the Board of Directors of Trust for America's Health, AcademyHealth, the Public Health Institute, and the CATCH Global Foundation.

Dr. Sanchez obtained his M.D. from the University of Texas (UT) Southwestern Medical School in Dallas, an M.P.H. from the UT Health Science Center at Houston School of Public Health, and an M.S. in biomedical engineering from Duke University. He holds a B.S. in biomedical engineering and a B.A. in chemistry from Boston University. Dr. Sanchez is board certified in family medicine.

Challenges to Integrating Technology in Healthcare Settings

Transforming Healthcare: Aligning Provider Culture

Mark S. Hernandez, MD, Chief Medical Officer for the Community Care Collaborative works with multiple clinicians and service organizations throughout Travis County to fulfill the goals of the Collaborative, which include transforming the delivery of care into an integrated system.

Dr. Hernandez started in healthcare in 1993, when he was licensed as a registered nurse and worked for the Harris County Hospital District and Ben Taub General Hospital in Houston as an intensive care nurse for 10 years. Dr. Hernandez, who graduated from Baylor College of Medicine in 2003, did his residency in Internal Medicine at University Medical Center Brackenridge and, upon graduation, served as chief resident. He entered general internal medicine practice with Scott & White Clinic in Pflugerville before returning to Seton in 2008 as an academic hospitalist at UMC Brackenridge. In 2011 he became the medical director for the UMC

Brackenridge hospitalist group. One year later, he was promoted to his current position, adding the hospital ambulatory clinics, including the Shivers Cancer Center and Infusion Suite, an internal medicine primary care clinic, numerous sub-specialty clinics and Seton Total Health Partners, a population health program to serve the needs of chronically ill under- and uninsured patients in Travis County to his list of responsibilities. Dr. Hernandez is board-certified in Internal Medicine. He holds academic appointments with the University of Texas Southwestern University and the University of Texas Medical Branch and is adjunct faculty with the University of Texas at Austin School of Nursing and active in advanced practice nursing student education.

Race Ethnicity & Language Data – How to use it to Deliver Culturally Competent Care in the Underserved

Guwan Jones, MPH, CHES



Guwan Jones is the Chief Diversity Officer of BaylorScott & White Health. She is an ongoing advocate for underserved and vulnerable patient populations. Through her work with three healthcare systems and other not-for-profits, she has worked on issues such as funding to increase access to health

insurance for children, focusing community resources on providing health care access for low socioeconomic populations, organizing resources for HIV/AIDS patients, designing meaningful interventions for minority diabetes patients, and designing analytic dashboards to measure human capital investment and patient outcomes.

Guwan has helped advance Baylor’s work around access and health care improvement and produced the Baylor Health Care System Health Equity Performance Analysis. She participated in the nationally recognized Disparities Leadership Program designed to tackle racial and ethnic disparities in health care lead by the Disparities Solutions Center at Massachusetts General Hospital in Boston, MA,. She served on the CitySquare board, an organization supporting basic needs for low-socioeconomic Dallas families and homeless communities. She was featured as a case study in the 2014 book *“Be the one to start change at work and in life: Make Waves”* because of her reputation of marrying the business case for working in parallel on the diverse needs of both talent and patients.

Guwan holds a Master of Public Health from the University of North Texas Health Science Center, Fort Worth and a Bachelor of Science in Health Science from the University of Arkansas at Fayetteville. Guwan is also a Certified Health Education Specialist and received the 2008 U.S. Surgeon General’s Healthy Youth for a Healthy Future Champion Award.
