There will be inspiring, innovative and informative sessions regarding engagement with rural Indigenous service providers to promote appeal rights; the indigenous experience at VCAT, the LGBTI Community and Tribunals, the Safewards Victoria program to improve the quality of interactions between staff and consumers in mental health settings; and several presentations on technology in tribunals with a focus on current and future initiatives which have the potential to change the landscape of Tribunal services and processes.

#### SPEAKER Michael Vallance, Manager, International Framework for Court Excellence, Supreme Court of Victoria.

This session will explore the relevance of the Court and Tribunal Excellence Frameworks to modern-day Tribunals.

The Tribunal Framework is an adaptation of the International Framework for Court Excellence, a quality management tool first developed for Courts and Tribunals by the International Consortium for Court Excellence in 2008.

The foundation of the Tribunal Excellence Framework is the clear statement of fundamental values tribunals must adhere to if they are to achieve excellence. The Framework presents eight detailed areas of tribunal excellence aligned with those values against which Australasian tribunals can voluntarily manage, assess and improve the quality of justice and tribunal administration.

The core values when considered in conjunction with the areas of excellence create a holistic management model that helps tribunal leaders to establish and maintain a culture that focuses on the pursuit of excellence.

The Framework is heavily predicated on measuring excellence through the concept of organisational self-assessment using a survey style questionnaire.

The features of the Framework are well documented within the 2nd Edition published by COAT in June 2017. The conference presentation will involve delegates in a conversation around the need to work on improving their business while they continue to operate in their day-to-day business. It will engage delegates in better understanding that the Framework is not a panacea for a tribunal's ills. It is simply a management model, but a really good one. And, it will challenge delegates to consider how they might interpret the Framework within the context of modern-day tribunals.

- Delegates will have an enhanced understanding of the value that excellence frameworks can bring to the performance of tribunals.
- Delegates will better appreciate the holistic nature of excellence frameworks and why they offer better value than many other management frameworks for tribunals.
- Delegates will recognise that effective use of an excellence framework can serve as a major contributor towards forming the desired culture within a tribunal.

Rodney and Robin will discuss the importance of tribunal processes being inclusive and welcoming to members of the LGBTI community. They will consider some of the ways in which systems and processes can inadvertently discourage members of this group from accessing justice or participating in processes through tribunals. This will include considering impacts on members of the LGBTI community of unconscious bias, the importance of well-informed members and staff, the best approaches to relationship recognition and gender recognition, and the risks of not being aware of legal obligations and equality rights principles more broadly. They will also address the issue of reflecting gender fluidity in case management systems.

# **Professor Tania Sourdin, Dean of the University of** Newcastle Law School

Professor Tania Sourdin, Dean, University of Newcastle Law School She was previously the Foundation Chair and Director of the Australian Centre for Justice Innovation (ACJI) at Monash University in Australia.

Professor Sourdin has led national research projects and produced important recommendations for justice reform. In the past two decades, she has conducted qualitative and quantitative research projects into aspects of the justice system systems in

11 Courts and Tribunals and five external dispute resolution schemes. Other research has focussed on justice innovation, technology, delay and systemic reforms.

Professor Sourdin is the author of books, articles and papers, and has published and presented widely on a range of topics including justice issues, mediation, conflict resolution, collaborative law, artificial intelligence, technology and organisational change. She is also a Visiting Professor at the University of Sydney and has worked as a senior Tribunal member in respect of appellate matters and as a mediator for more than 25 years. She has worked extensively overseas as an expert consultant in relation to dispute and dispute system design. In 2014 she was appointed as the National Broadband Network (NBN) Industry Dispute Adviser in Australia and also co-chaired the 2014 National Mediation Conference. In 2015 she won the Deans award for Research Impact in relation to her work on behavioural change in the justice sector.



## The Honourable Justice Judy Hughes, President, South Australian Civil & Administrative Tribunal (SACAT)

The Honourable Justice Judy Hughes was born and raised in Adelaide and graduated from the University of Adelaide in 1991 with an Honours degree in Law and a Bachelor of Arts specialising in philosophy and politics. Her early career was spent working in private legal practice and for Government at the Crown Solicitor's Office. She has also undertaken policy development roles within Government, and worked in the Attorney-General's Office. Between 2000 and 2006, she was Deputy

Commissioner for Consumer and Business Affairs, and in that role was closely involved in real estate reforms, industry regulation, incorporated associations and consumer law.

Justice Hughes returned to work with the Crown Solicitor's Office in 2006 as an Executive Solicitor, managing a team of lawyers in the areas of State taxes, freedom of information, and judicial review of administrative decisions. She was appointed Crown Solicitor in April 2017, overseeing an office of 280 staff, before being appointed to the Supreme Court and as President of SACAT in July 2017.

# Dr Lewis O'Brien AO

Uncle Lewis Yerloburka O'Brien is a Kaurna Elder born at Point Pearce. Named Aboriginal Elder of the Year in 1977, awarded 'Local Hero' Australia Day Awards in 2003, Fellow of the University of SA in 2004, Citizen of Humanity Awarded by the National Committee of Human Rights in 2009 and an Order of Australia Medal in 2014. Uncle Lewis is widely regarded as a leader of reconciliation and custodian of Kaurna culture.



# The Honourable John Rau MP

The Honourable John Rau MP is the South Australian Deputy Premier, Attorney-General, Minister for Justice Reform, Minister for Planning, Minister for Industrial Relations, Minister for Child Protection Reform, Minister for the Public Sector, Minister for Consumer and Business Services and the Minister for the City of Adelaide.

After completing his law degree, John worked at legal firms Duncan & Hannon and later at Johnston Withers & Associates, where he was made a partner. He was an adviser to the Hawke Government from 1985-1988, and has been a Barrister since 1997. In 2002, he

was elected to the South Australian House of Assembly where he served on various Parliamentary Committees until being appointed to the Ministry in March 2010. John is a former member of the ALP National Executive. He was appointed Deputy Premier in February 2011.

## *The Honourable Justice Greg Garde, President, Victorian Civil & Administrative Tribunal (VCAT)*

Justice Greg Garde AO RFD. Justice Garde was appointed a Justice of the Supreme Court of Victoria on 29 May 2012. Before His Honour's appointment to the Supreme Court, he was a practising Queens Counsel. Justice Garde signed the Victorian Bar Roll in 1974, and was appointed a Queens Counsel in 1989.

Justice Garde has also lectured in Administrative and Constitutional Law. His Honour is a former Chairman of the Planning and Local Government Committee of the Commercial

Bar Association and of the Bar's Law Reform Committee. His Honour is a former President of the Victorian Chapter of the Council of Australasian Tribunals. He was appointed President of VCAT on 1 June 2012 for five years. His Honour was reappointed as President for a further year in May this year and is now VCAT's longest serving president.



# Michael Vallance, Manager, International Framework for Court Excellence, Supreme Court of Victoria

Mike is the Manager, International Framework for Court Excellence with the Supreme Court of Victoria in Australia; a dedicated full-time role implementing the Framework as the Court's foundation management model. Significant emphasis is also being placed on implementing the global measures of court performance as the court's suite of key performance indicators.

Previously, Mike was the General Manager, Change Management with Corrections Victoria in the Department of Justice, Victoria. With 2,100 staff spread across 68 locations, including 11 prisons, Mike helped guide the organisation to a Silver Award in the Australian Business Excellence Awards; the first correctional jurisdiction in the world to gain award level status in any national business excellence awards program. Mike has also been a Lead Evaluator in the Australian Business Excellence Awards, holds multiple quality management qualifications, is a lead assessor in ISO quality management systems and has completed training in six sigma and the balanced scorecard.



# *Keryn Negri, Chief Executive Officer, Victorian Civil and Administrative Tribunal (VCAT)*

Over a fifteen-year career in the Victorian Public Service, Keryn has worked across a broad array of social policy areas including aged care, employment, health, indigenous affairs, emergency management and consumer affairs, driving a number of major reform projects.

She has worked in several departments including health and human services, education and Premier and Cabinet, with the past decade spent predominately in the Department

of Justice. Keryn has extensive management experience, a comprehensive understanding of how government works and a passion for driving public sector excellence, leadership and reform.



# Mary Shortland, Executive Director, Queensland Civil and Administrative Tribunal (QCAT)

Mary Shortland has been the Executive Director of the Queensland Civil and Administrative Tribunal for seven years and has extensive executive experience in implementing major Government and Private sector reforms.

Prior to joining the tribunal Ms Shortland had key executive roles in the Brisbane City Council and a number of International companies including Dairy Crest UK Ltd and DHL International.

Ms Shortland is a member of the Chartered Institute of Cost and Management Accountants and a member of the Australian Institute of Company Directors.

# Sian Leathem, current Registrar of the AAT for a five-year term which commenced on 7 April 2015

Her role is to assist the President to manage the Tribunal and advise on its operations and performance. The Registrar may act on behalf of the President in relation to the administration of the Tribunal.

Ms Leathem has over ten years' experience in tribunal management at both state (NSW) and federal level. She led the project team responsible for merging twenty-two existing tribunals into the New South Wales Civil and Administrative Tribunal (NCAT) and performed

the role of Principal Registrar of that amalgamated Tribunal. Prior to her role at NCAT, Ms Leathem was the Registrar of the Workers Compensation Commission of NSW for five years.

Ms Leathem has relevant experience of the Commonwealth administrative review system and governance, finance, staffing and administrative arrangements, gained in her role as Assistant Registrar of the AAT over three years. She also has a wealth of legal policy experience that she gained through various roles in the NSW Attorney General's Department and in the Department of Prime Minister and Cabinet.

In 2002 Ms Leathem was awarded the Excellence in Government Legal Service Award by the Law Society of New South Wales and in 2014 she received the Excellence in Leadership Award from the NSW Department of Justice. She was also awarded the Young Public Sector Leader Award by the Institute of Public Administration Australia in 2011.

#### Adrian Sculthorpe, Senior Manager, PwC's Indigenous Consulting

Adrian is a Palawa (Tasmanian Aboriginal) man and Senior Manager with PwC's Indigenous Consulting (PIC). PIC is a national Indigenous consulting business that is majority Aboriginal owned and staffed, and is also a member firm of the PricewaterhouseCoopers global network. Adrian's previous work experience has included a diverse range of roles across Victoria and Tasmania, with a focus on improving justice outcomes for Aboriginal people by ensuring programs and services are provided

in a culturally inclusive and accessible manner. He has over 10 years' experience working in management and operational roles to develop and implement initiatives of the highly regarded Victorian Aboriginal Justice Agreement (AJA).

Adrian's recent project experience with PIC has included: VCAT Aboriginal and Torres Strait Islander Engagement Project; Unlock The Facts on Indigenous Incarceration (a national, public report www.unlockthefacts.com.au); Refresh of the Wulgunggo Ngalu Operating Manual; Aboriginal Prisoner Transitional Housing Project Workshops; Ravenhall Correctional Centre Aboriginal Programs Service Delivery Model; and Induction Manuals and Professional Development Program for Aboriginal Community Justice Workers.



# *Ian Phillips, Acting District Registrar, Administrative Appeals Tribunal (AAT)*

Ian has had a varied career working in both Federal and State Governments. He has worked for the Social Security Appeals Tribunal and the merged AAT since 2013 as the District Registrar for Social Security matters. From 2008 to 2013, Ian held the position of Registrar of the District Court, Environment Resource and Development Court, Equal Opportunities Tribunal, Police Disciplinary Tribunal and the Protective Security Officers Disciplinary Tribunal. From 2004 to 2007 Ian was the director of Public Sector Reform in

Premier and Cabinet. He also has had experience as a Deputy Commissioner of Consumer

Affairs and Manager of Corporate Affairs and Compliance. Prior to this from 1999-2002 he was an investigator at the Australian Competition and Consumer Commission. He has had a long-standing interest in working with the indigenous members of the community to improve access to justice.



## Roula Karzis-Wyatt, Team Leader, Administrative Appeals Tribunal (AAT)

Roula commenced working in the Social Security Appeals Tribunal in January 2007, having previously been employed by Centrelink and the Child Support Agency for 8 years. Prior to that Roula had 12 years' experience as a child protection social worker and family preservation worker in the Riverland and Elizabeth/Gawler region.

Over the last 10 years Roula established and coordinated a localised outreach program for the SSAT and now Social Services and Child Support Division of the Administrative

Appeals Tribunal. They conducted targeted community outreach to educate community and government service providers and workers who interact with the vulnerable members of the community about the review rights available.

Outreach has been conducted in partnership with other legal advisory and social welfare groups including Welfare Rights Inc., Brain Injury Network of SA and Wyatt Foundation, and the AAT General Division. The success of this outreach programme is shown in an increasing number of reviews from the remote and rural indigenous communities in South Australia. Access to justice is Roula's great passion.



## **Rodney Croome AM**

Rodney Croome is one of Australia's leading advocates for the human rights of gay, lesbian, bisexual and transgender people. He is the former national director of Australian Marriage Equality. He has left to fight a marriage equality plebiscite and remains a campaigner for LGBTI rights.

Rodney has worked closely with a number of different Tasmanian government agencies on LGBTI policy development over the past 20 years.

In recognition of his work he was made a Member of the Order of Australia in 2003 and was named Tasmanian Australian of the Year 2015. Rodney grew up on a dairy farm in North West Tasmania and is a graduate of the University of Tasmania. He lives with his partner Rafael in South Hobart.



# Robin Banks

Robin has recently completed over six years as Tasmania's third Anti-Discrimination Commissioner.

Before returning to Tasmania in 2010, Robin was the Chief Executive Officer of the Public Interest Advocacy Centre where she led the centre's work in human rights, public interest law, social justice and inclusion, at both the level of individual rights protection and of systemic reform. This work included identifying ways in which systems and processes inadvertently create barrier to inclusion and working to remove those barriers. In

2007, Robin was shortlisted for the Federal Human Rights Community Award.

Robin has worked for more than 30 years in rights advocacy. She has been a lawyer since 2000 with experience in both the private and public sector including as an employment and discrimination litigation senior associate;

a legal researcher at the Canadian Human Rights Commission; an advocate for people with disability in Alice Springs, and as the co-ordinator of the NSW Disability Discrimination Legal Centre.

Throughout her working life, Robin has worked across sectors to promote understanding of and compliance with human rights and particularly equality rights and discrimination law. Through this work, Robin seeks to enhance opportunities for all in our community to be active and welcomed participants in civil and democratic society.

Robin continues to work on social justice and human rights issues and campaigns. She is an active member of the current campaign for a human rights act for Tasmania and is national co-convenor of Australian Lawyers for Human Rights, human rights sub-committee. Robin also works with Michael Small Consulting Pty Ltd supporting organisations to respond to their human rights and discrimination law obligations, including improving their accessibility and inclusive practices. She has recently been appointed as a University Associate to the College of Arts and Law at the University of Tasmania.

In her work, Robin draws on a wealth of experience as a manager, a specialist lawyer and a policy analyst.


