





## **Continuing Education:**

Certified Peer Recovery Specialist: This seminar is pending approval for Continuing Education Hours toward Certified Peer Recover Specialist Renewal.

Mental Health Academy is the outreach and programming arm of MHAMT that provides Continuing Education (CEUs) curricula for therapists, social workers, attorneys, and other professionals whose work involves mental health awareness.

Mental Health Academy seeks to offer twelve to fourteen such events a year, focusing on issues relevant to these various professional practitioners. These affordable programs will be held throughout the mid-state area as well as other parts of Tennessee.

The programs, half- or full days, are certified by the professional boards licensing the targeted professions and will generally provide three to six hours of CEU credit each. Speakers are chosen for their expertise in specific areas and their awareness of the current needs among the professions.



## **Seminar Directions:**

From I-65 north of Downtown Nashville, take Exit 92 (Madison/Old Hickory Boulevard) and go east on Old Hickory for approximately 3 miles. (You will cross over Gallatin Road). At the 3<sup>rd</sup> light, turn right on Larkin Springs Road. Go 0.6 miles and take a left on Hospital Drive. Once on campus, look for the Medical Office Building (MOB), located at 510 Hospital Dr. It is a red-brick building with rounded glass. On the 4th Floor you will find the Magnolia Room where the seminar will take place.

**Nicole Cobb, EdD,** is Executive Director of School Counseling for Metro Nashville Public Schools and an Adjunct Professor at Vanderbilt University. She previously worked at Educational Testing Service in Princeton, NJ, and with the State of Tennessee Department of Education. She serves on First Lady Michelle Obama's Reach Higher advisory council.

**Richard Bulzacchelli, STD**, is Associate Professor of Theology at Aquinas College, in Nashville. He is a popular classroom teacher and public speaker, and is published on topics ranging from medical ethics to Pope John Paul II.

**Anna Edgeston, LPC, EdD,** is Assistant Professor in Counselor Education at Argosy University in Nashville, and is on the Adjunct Faculty at Middle Tennessee State University. She was named co-winner of the Emerging Leader award by the Tennessee Association for Counselor Education and Supervision.

**Jamie Langley, LCSW**, is transitioning to private practice after more than 25 years at The Guidance Center in Murfreesboro. She is a Registered Play Therapist—Supervisor and is president of the Tennessee Association for Play Therapy.

**Tim Takacs, JD, CELA,** is a Certified Elder Law Attorney and was among the nation's first attorneys to assembled a multi-disciplinary staff to offer integrative client care. His "elder-centered" practice focuses on maximizing elders' lives and independence. He was a charter member of the Special Needs Alliance, a network of influential disability attorneys.
