Continuing Education:

Certified Peer Recovery Specialists: This seminar has been approved for Continuing Education Hours toward Certified Peer Recover Specialist Renewal.

The programs, half- or full days, are certified by the professional boards licensing the targeted professions and will generally provide three to six hours of CEU credit each. Speakers are chosen for their expertise in specific areas and their awareness of the current needs among the professions.
