Session 1 Panel Discussion: Year in review

Over the past 12 months there have been a number of significant legal developments relevant to the construction industry with respect to:

- major legislative reforms and recommendations related to Security of Payment and conflicting decisions of the Courts across Australia in relation to insolvency events;
- the emergence of the NEC contract in Australia;
- clarity with respect to the strict adherence to form when issuing contractual notices;
- the refusal of the Rocky Hill project and how this will impact the broader NSW resources sector; and
- the endorsement of collaborative contracting by the NSW State Government and how these Model Procurement Rules will be applied to future projects.

Our panel will discuss how these developments have impacted, and will continue to affect industry stakeholders. We will explore the practical effects of the key recent cases and legislative changes.

Session 2 Panel Discussion: Big Data, Al and the Construction Industry - Opportunities and Risks

An increasing number of projects are adopting innovation to better collect, analyse and harness their data with a view to driving smarter project management, safety and other processes. The construction and infrastructure sector has been an intelligent early adopter of technologies such as "The Internet of Things" and predictive analytics, and has leveraged these to enhance the delivery of significant projects in Australia and abroad. Session 3

Paper: Security of Payment
