PROFESSOR CHRISTOPHER SYMES

Christopher has written textbooks and numerous articles for both an academic and practitioner readership on Personal and Corporate Insolvency. Christopher's book Australian Insolvency Law, co-written with John Duns, is now in its third edition. He is also a co-author of Corporations Law In Principle and Business and Corporations Law and is co-author of Australian Insolvency Law Cases and Materials.

Christopher previously worked as an accountant and practised as a commercial lawyer. His academic career has traversed both Business and Law schools, teaching in a variety of commercial law compulsory and optional topics both in Australia and Malaysia. He has been Deputy Dean of Flinders Law School and Deputy Dean and Director of Adelaide Law School.

Christopher continues his involvement with the ARITA and the Law Council's Insolvency and Reconstruction Committee. He is editor of the Australian Journal of Corporate Law and the past editor of the Insolvency Law Bulletin. Since 2010 Christopher has been co-director of BILS, now known as ROCIT.



DR. MALCOLM QUIREY

Malcolm is Special Counsel of Piper Alderman. Having practised extensively in several legal areas (security, finance, property, joint venture and corporate law) Malcolm has complemented his practice career with tertiary sector appointments with twelve universities across four States.

Malcolm is a legal practitioner of 30 years standing and has practised across several areas of legal practice including Administrative Law, Banking and Finance, Corporate Law, Commercial Litigation, Equity, Securities Law and, significantly, Insolvency Law and Debt Agreements.

He is particularly adept at contracts, property, infrastructure, and joint venture/public private partnerships and is masterly at law reform and legal educator tasks.



ASSOCIATE PROFESSOR DAVID BROWN

David trained at the English Chancery and Commercial Bar and was a part-time Lecturer in Land Law at Merton College Oxford. In 1996 he emigrated to New Zealand and became a Senior Lecturer at Victoria University of Wellington and, between 2001-2003, he was Deputy Dean of the Faculty of Law. Since 1999 David was a consultant to the Government's Insolvency law review, and an adviser to the New Zealand Law Commission on insolvency law reform. He co-authored several leading books on New Zealand Land Law and Insolvency Law during this time.

In 2009 he moved to Adelaide, where he has continued to teach Insolvency Law at a Masters level as well as Corporate Law and Property Law. He also teaches Personal Properties Securities Law. Since 2009 he has been a member of the Law Council of Australia's Insolvency and Restructuring Committee, and an Academic Member of ARITA. Since 2010, David has been co-director of Australia's first and only research unit, Bankruptcy and Insolvency Scholarship Unit (BILS) now known as ROCIT (Regulation of Corporate, Insolvency and Taxation).



DR. SYLVIA VILLIOS

Sylvia is a lecturer at the Adelaide Law School, University of Adelaide and teaches taxation law, estates, and wealth planning law. Prior to her appointment as a lecturer, Sylvia was engaged in legal practice for 6 years at two of Adelaide's leading law firms, specialising in advising clients on taxation, trust law, superannuation and general corporate and commercial matters.

Sylvia recently completed her PhD titled 'A Framework for Corporation Insolvency Taxation: The Crossroad of the Theoretical Perspectives in Taxation Law and Insolvency Law' under the primary supervision of Christopher Symes at the University of Adelaide.



VIVIENNE BRAND

Vivienne Brand is a corporate law academic at Flinders Law School, with a long-standing research interest in corporate whistleblowing as a regulatory mechanism. Vivienne has written on a range of issues related to corporate whistleblowing, and together with Sulette has published on whistleblowing bounties and appeared before parliamentary inquiries investigating whistleblowing reform.



SULETTE LOMBARD

Sulette Lombard is a senior lecturer at Flinders Law School, teaching Corporate Law and Insolvency Law. Her research interests include corporate regulation and governance, and recently, particularly the connection between good governance and institutional whistleblowing frameworks. Along with Vivienne, Sulette was involved in parliamentary inquiries into whistleblowing reform.



KERRY ANTONIOU

Following her admission, Kerry worked as a District Court Legal Associate and then as a Family Court Legal Associate before entering private practice as a lawyer working exclusively in the area of family law. In 2015, Kerry established Alpha Family Lawyers. She is the Principal Lawyer | Director of the firm.

Kerry is also an Associate Teacher in the Law School at the University of Adelaide where she has been teaching family law since 2002. She is also the External Co-ordinator for the Family Law Course offered in the Graduate Diploma in Legal Practice (GDLP) which is run by the Law Society of South Australia and the University of Adelaide. She has been involved with the GDLP programme since 2002. In 2016, Kerry was awarded a Faculty of Profession (School of Law) Executive Dean's Award for excellence in teaching.
