#### **Cancellations**

## **Data protection**

Research Instruments does not collect any unique information about you (such as your name, e-mail address etc), except when you specifically and knowingly provide such information. Our website uses 'cookies' small text files or variables which enable a website to remember who you are. Most browsers are automatically set to accept cookies, but if you are using Microsoft's Internet Explorer or Netscape Navigator, you should be able to configure your browser to restrict cookies or block all cookies if you wish. This will however, affect your ability to log into and use any restricted areas of our website. We use session cookies (which are temporary cookies) to maintain your session with the server in the areas of our site that are available to registered users. Our session cookies store a unique identifier to allow the server to distinguish between individual users' sessions. Session cookies are deleted when you close your browser. No cookies on our site are served or used by third parties.

Through website statistics we do keep a record of traffic data which is logged automatically by our server, such as your IP address, the URL you visited before ours, the URL you visit after leaving our site and which pages you visit. We also collect some site statistics such as page hits and page views. We are not readily able to identify any individual from traffic data or site statistics.

# Contacting us by other methods other than the website

The website provides various telephone numbers and email addresses for you to contact us. We will collect information from you through any of these methods. We may also collect other information you supply to us after your initial contact with us.

## Links to other sites
