indirectly from the Event, whether related to the Audio & Video Material of Organizer or others or Organizer Activities or any other illness or injury or otherwise.

In further consideration of the admittance benefits in the Event, I hereby waive, release, discharge and agree to indemnify and hold harmless Organizers, successors, assigns, officers and employees, from any and all actions, suits, claims and demands of any kind whatsoever, which I, my heirs, executors, administrators and assigns, had, now have or hereafter may have, by reason of any negligent acts or omissions of Organizer in connection with the Event, including but not limited to the operation of the Event, the awarding of prizes and other gift items such as 'swags', and any action, claim or suit for personal injury or loss or damage to property in connection with my participation in the Event.
