8:30 – 8:45 WELCOME AND OPENING REMARKS

8:45 – 9:45 Contemporary Developments in Clinical Suicide Prevention

David A. Jobes, PhD, ABPP

Trends in health care are creating unique challenges and potential responses to effectively managing suicidal risk across a spectrum of care. This plenary will review recent developments in policy, theory, and research related to clinical work with individuals who are suicidal. Advances in suicide risk assessment and treatment will be discussed and future directions will be explored.

10:00 – 11:00 Suicide and Suicide Prevention in Older Adults

Carol Podgorski, PhD, MPH, MS MFT

In this plenary presentation, Dr. Podgorski will focus on a two-pronged approach to suicide prevention in older adults—promoting mental health and reducing risk factors. She will provide an overview of suicide in older adults, the risk factors for suicide, and the prevalence of mental disorders in community-dwelling older adults. She will also discuss how aging service professionals are well positioned to contribute to suicide prevention efforts in the populations they serve. Emphasis will be on interventions that aging service professionals can use in primary prevention of suicide by creating healthier communities for older adults.

11:15 - 12:30 WORKSHOP 1: SESSION A

A1: The Collaborative Assessment and Management of Suicidality (CAMS) David A. Jobes, PhD, ABPP

This workshop will present an evidence-based approach to effectively working with suicide risk using the "CAMS" approach to care. With 25 years of research support, CAMS is both a philosophy of care and clinical framework for assessing, tracking, and treating suicidal risk to outcomes. Using CAMS also ensures ethical and competent care with implications for decreasing the risk of malpractice liability therein.

A2: Grief After Suicide: Walking the Journey with Survivors – John R. Jordan, PhD This workshop will provide a focused overview of the impact of suicide on survivors, and the clinical and support responses that are needed after a suicide occurs. The workshop is geared primarily towards clinicians working with suicide bereavement, but will be suitable for survivors who want to learn more about the impact of suicide, and the recovery process afterward.

A3: Working Together: Law Enforcement and Mental Health/Crisis Services Officer Christopher Guay, Tara Mitchell, BSW, MHRT CSP, Lt. Janine Roberts, Robert Rocket, LCSW, Deputy Chief Charles Rumsey – Moderated by Steve Addario, LCSW This timely discussion will highlight effective models of collaboration between local law enforcement and the regional crisis teams in their areas. Representatives from the Waterville, Augusta and Portland Police Departments, together with professional crisis workers from Crisis and Counseling (located in Augusta) and The Opportunity Alliance (located in Portland) will explore how each system has learned from each other and improved practices when responding to community crisis needs. These teams will share their experiences and highlight practices that help blend cultural understandings (law enforcement and social service) and ethical and legal requirements of each system. They will share their experiences of what has been working and what are some of the ongoing challenges. Attendees will gain an increased understanding of police and crisis response as well as learn best ways to utilize these services when concerns arise for someone requiring outside intervention. You will also learn about the training programs (CIT – Crisis Intervention Team training) that are used to increase awareness and improve crisis response. There will be time for discussion following the presentations.

A4: Using the eC-SSRS: Practical/Operational/Data Considerations Michael Federico, MS

Following last year's Beyond the Basics keynote presentation by Kelly Posner, PhD., this session will explore the experience and insight gained from over 100,000 assessments of 32,000 patients using the eC-SSRS. This patient self-rated/ePRO approach addresses the challenges of conducting consistent interviews, differentiating attempts from non-suicidal self-injurious behaviors (NSSIB), and implementing a broad scale screening and routine assessment program. The value of the resulting data, documenting how each ideation and behavior question contributes to understanding the risk of impending suicidal behavior, will also be presented.

A5: The Basics of School-based Suicide Awareness and Prevention including Maine's New Training Law – Susan Berry, BS

This session will provide the audience with an overview of Maine's new suicide awareness and prevention training law for school personnel that goes into effect at the start of the 2014–15 school year for high schools and the 2015–16 school

year for elementary and middle schools. The law is one supporting component of Maine's comprehensive school-based suicide prevention program. During this session participants will gain an understanding of the overall program; engage in a review of available school resources; and discuss strategies for saving lives through a school and community approach to prevention.

A6: LGBTQ Youth: Safe and Accepted – Jeanne Dooley, MSW, Sarah Holmes, MS, Betsy Parsons, BA, MAT, CAS, MaKayla Reed – Moderated by Heather Carter, MA LGBTQ identified youth in Maine report three times the rate of suicide attempts than their peers. Schools and community members can help address this issue through acceptance and by identifying supportive resources in their communities. Panelists from Out as I want to Be, GLSEN, EqualityMaine and the Trevor Project Youth Advisory Council, and USM Center for Sexualities and Gender Diversity will talk about how best to support LGBTQ youth in our schools and communities and identify the resources in their areas that could be most supportive to this population. Through support and acceptance we can make a difference.

2:15 - 3:30 WORKSHOP 2: SESSION B

B1: Implementing the C-SSRS: From Crisis, to the Emergency Room, and into the Psychiatric Hospital – Geoffrey Nappi, LCPC, James Wolak, MD, Robert McCarley, MD – Moderated by Rebecca Emmons, MPH

The Psychometric Properties of the Columbia-Suicide Severity Rating Scale (C-SSRS) are used extensively across primary care, clinical practice, surveillance, research, and institutional settings. The C-SSRS has been associated with decreased burden by reducing unnecessary interventions and redirecting limited resources. Following last year's Beyond the Basics presentation by one of its developers, Dr. Kelly Posner, more sites have implemented the scale here in Maine. This panel, with representatives from a behavioral health emergency room, a psychiatric hospital and a crisis provider will explore why they have adopted the scale, how it is being used and what have been their experiences using the scale.

B2: Suicide Prevention in Senior Living Communities – Carl Podgorski, PhD, MPH, MS This session will address competencies and skills that aging service professionals need to become competent and comfortable creating senior living communities that promote good mental health and prevent risk for suicide among residents. This

presentation will consist of an overview of principles of suicide prevention and risk reduction as published in the SAMHSA publication Promoting Emotional Health and Preventing Suicide: A Toolkit for Senior Living Communities. The session will include an interactive discussion involving a case scenario that will provide participants an opportunity to apply the principles from the toolkit to an actual case.

B3: Sexual Violence, Slut-Shaming, and Suicide Prevention – Cara Courchesne Over the last few years, media reports of teens who kill themselves because of gender-based bullying, sexual harassment, and/or sexual violence have increased. This session is designed to explore the intersections of sexual violence and suicide and how prevention education can help to prevent sexual violence and suicide.

B4: Postvention Needs of School Communities following a Student Suicide Heather Perry, Amber McGowan, Mimi Sorg, LCSW – Moderated by Greg Marley, LCSW

The suicide death of a student is a tragic crisis that every school hopes it never has to face. Unfortunately, Maine faces several such losses every year, and it is of enormous benefit for a school system to be prepared for the tidal wave of grief and need that comes with such a loss. The concern over contagion must be taken very seriously. This session will feature speakers from schools across Maine that have weathered the storm of suicide postvention and are prepared to talk about what was needed, what was helpful and also what challenges they faced as they worked to support the needs of the students, staff and community. There will be time for discussion for those attending.

B5: Child and Adolescent Suicide: Risks, Intervention and Prevention Michael Mitchell, LCSW

Although child and adolescent suicide is relatively rare, it is a leading cause of youth deaths worldwide. Research has shown that effective identification and intervention can have a significant impact on youth suicide. The effectiveness of these efforts is grounded in a thorough understanding of risk factors associated with youth suicide and best practice informed interventions. This workshop will review our current understanding of child and adolescent suicide and it relationship to treatment and prevention.

Speakers



Steve Addario, LCSW

Steve Addario is the Director of Crisis Intervention Services, The Opportunity Alliance, providing crisis intervention services for adults in Cumberland County. His crisis team includes mobile outreach staff that is available 24/7, office based crisis clinicians providing intensive follow-up care utilizing Acceptance and Commitment Therapy (an evidence based treatment model), Peer and Family Navigators providing real life experience and supports as well as a crisis worker specialized in community resources. Mr. Addario is a Graduate of Boston University, School of Social Work (MSW program). He has more than 14 years of experience in crisis intervention services and has been providing a variety of social work services for almost 30 years. His training includes suicide assessment, intervention and prevention, trauma response and disaster mental health services. His experience includes volunteer and employment service in Violence Recovery, Hospice Care, Nephrology Social Work and group work with children and families grieving the loss of a loved one. Mr. Addario started his professional career with a Bachelor degree in education and experience as a junior high school teacher.



Susan Berry, BS

Susan Berry has worked in the health education field for more than 25 years. Her experiences include working as a Family Life Educator for a local Family Planning Agency; Middle School Health Education Teacher; School Health Coordinator and 12 years at the MDOE as a Health Education Consultant, Director of Coordinated School Health Programs and currently the Health Education and Health Promotion Coordinator. Susan has served on local, state and national committees focused on school health education. She has been involved in the development and delivery of school based suicide awareness and prevention training for 17 years and serves on the Maine Suicide Prevention Advisory Council. Susan is a long-time advocate of prevention efforts in order to support healthy students, healthy staff and healthy schools.



Heather Carter, MA

Heather Carter comes to NAMI Maine from Washington State, where she ran a program focused on youth suicide prevention within high risk populations. Heather has a BA in Sociology with a focus on Intercultural Relations and a MA in Intercultural Service, Leadership, and Management with a focus on Training & Intercultural Communication. She has many years of experience working in mental health prior to her work in public health education and really found her passion when she began her work in suicide prevention.

Cara Courchesne, BA

Cara Courchesne is the Communications Director at the Maine Coalition Against Sexual Assault and focuses her work on statewide communication regarding sexual violence by providing technical assistance to Maine's sexual violence service providers and Maine media. She has worked for anti-violence nonprofits in Maine since 2007 and has been in the anti-sexual violence movement for over a decade. Cara holds a BA in the Study of Women and Gender from Smith College



Jeanne Dooley, MSW

Jeanne Dooley is the Executive Director of Out! As I Want to Be, a non-profit organization supporting and empowering LGBTQ youth in the mid-coast Maine areas of Lincoln, Knox and Waldo counties. Located in Rockland, Out! hosts a twice-weekly drop-in program, a weekly radio show, and provides leadership and personal development programs for LGBTQ youth. Jeanne was on the Board of Directors of Out! for a year before taking the Executive Director position. She has a private practice that provides organizational and individual consulting, as well as extensive experience in providing strategic planning, training, marketing and volunteer management for organizations such as AARP and the American Bar Association. She lives with her partner in Waldoboro, Maine.



Rebecca Emmons, MPH

Rebecca Emmons is the Director of Continuous Quality Improvement at the Maine Primary Care Association. In this position Rebecca provides oversight of FQHC technical assistance for Patient Centered Medical Home transformation and recognition as well as supporting Maine's Multi-payer Patient Centered Medical Home Pilot and the MaineCare Health Homes Initiative. She provides coaching and technical assistance for quality improvement initiatives across Maine's Federally Qualified Health Center system and manages other supporting initiatives such as suicide prevention in rural primary care and behavioral health integration.



Michael Federico, MS

Michael Federico is responsible for managing all aspects of healthcare applications at ERT, including product development, operations and sales. Under his leadership, the healthcare group has organized ERT's capabilities into products and services to provide the complete patient experience for suicide risk assessment. Prior to his current position, Michael was Vice President of electronic patient outcomes solutions at ERT. Prior to joining ERT, Michael spent over 20 years in systems design, evaluation and equipment management in the healthcare field. He holds Bachelors and Masters Degrees in Engineering from Rensselaer Polytechnic Institute in Troy, New York.



Officer Christopher Guay

Officer Christopher Guay is a nine year veteran of the Augusta Police Department and a 2006 graduate of the Maine Criminal Justice Academy. He was born in Rumford, Maine and has lived most of his life in Maine, except for serving four years in the United States Navy during Desert Storm. Officer Guay graduated from the University of Southern Maine with a bachelor's degree in Criminology. During his time with the Augusta Police Department Officer Guay has completed training in C.I.T. and Child C.I.T. He now volunteers his time as a C.I.T. instructor for NAMI-Maine, throughout Maine and at the Maine Criminal Justice Academy. Officer Guay is also a training officer within his department and serves as a member of the Augusta PD Special Response and Tactics (SRT) Team. Officer Guay received Crisis and Counseling's 2013 Public Safety Appreciation award as well as the NAMI Laney Barnes Award for First Responder of the Year for 2013.



Sarah Holmes, MS

Sarah Holmes is the Coordinator for the Center for Sexualities and Gender Diversity at the University of Southern Maine, a position she has held since 2006. Previously as an undergraduate student at the University, she became involved with the campus' Alliance student group, was an active leader in student government, founded the USM Safe Zone Project, and participated in Dialogues in Diversity. As a graduate student in Adult Education, she also worked as the Tradebook Assistant for the USM Bookstore and then Administrative Assistant and Assistant to the Area Director of Portland Hall, During that time, Ms. Holmes advised the Alliance student group, co-coordinated two Northeast Regional LGBT Student Leadership Conferences, and advocated for the creation of a LGBTQA Resource Center. From 2000 to 2002, she served as the first coordinator of that center. In 2002, following completion of her Master's degree, she was selected as a Vaid Research Fellow for the NGLTF Policy Institute in New York City. Her work focused on the experiences of LGBTQ youth in K-12 education and resulted in a 2004 article published in the Journal of Gay and Lesbian Issues in Education. Currently, her active involvement in the community includes being a founding member of the Annual Portland Dyke March, serving as a board member for the Southern Maine chapter of the Gay Lesbian Straight Education Network (GLSEN), and as an adult advisor for the Proud Rainbow Youth of Southern Maine.



David A. Jobes, PhD, ABPP | Keynote Speaker

David A. Jobes is a Professor of Psychology and Associate Director of Clinical Training at The Catholic University of America. His research and writing in suicide has produced numerous peer reviewed publications (including five books on clinical suicidology). As an internationally recognized suicidologist, Dr. Jobes is a past President of the American Association of Suicidology (AAS) and is the recipient of that organization's 1995 "Edwin Shneidman Award" in recognition of early career contribution to suicide research. Dr. Jobes is also the recipient of the 2012 AAS "Dublin Award" in recognition of career contribution in suicidology. He has served as a research consultant to the Centers for Disease Control and Prevention and has been a consultant to the Institute of Medicine of the National Academy of Sciences, the FBI, the Department of Defense and Veterans Affairs. Dr. Jobes is Fellow of the American Psychological Association and he is board certified in clinical psychology (American Board of Professional Psychology). He maintains a private clinical and forensic practice at the Washington Psychological Center.



John R. Jordan, PhD

Jack Jordan is a licensed psychologist in private practice in Wellesley, MA, and Pawtucket, RI, where he specializes in working with loss and bereavement. Jack is the Clinical Consultant for Grief Support Services of the Samaritans in Boston, where he is helping to develop innovative outreach and support programs for suicide survivors. Jack is also the Professional Advisor to the Survivor Council of the American Foundation for Suicide Prevention (AFSP), and a former Board member of AFSP (New England Affiliate) and ADEC. For over 30 years, Jack has provided training nationally and internationally for therapists, healthcare professionals, and clergy through PESI Healthcare/CMI Education, the American Foundation for Suicide Prevention, and as an independent speaker. He has also helped to organize and lead many healing workshops for suicide survivors. Jack has published over 40 clinical and research articles, chapters, and full books in the areas of bereavement after suicide, support group models, the integration of research and practice in thanatology, and loss in

family and larger social systems. He has published in professional journals such as Omega, Death Studies, Suicide and Life-Threatening Behavior, Psychiatric Annals, Crisis, Grief Matters, and Family Process. He is the co-author, with Bob Baugher, of After Suicide Loss: Coping with Your Grief, a self-published book on suicide bereavement for surviving friends and family. He is the co-editor, with John McIntosh, of the book Grief After Suicide: Coping with the Consequences and Caring for the Survivors (Routledge, 2011), a professional book on the impact of suicide and interventions to help suicide survivors. He is also the co-author with William Feigelman, John McIntosh, and Beverly Feigelman, of Devastating Losses: How Parents Cope With the Death of a Child to Suicide or Drugs (Springer, 2012).



Greg A. Marley, LCSW

Greg Marley is the Clinical Director of NAMI Maine, and the Training Director of the Maine Suicide Prevention Program. Greg has practiced in the field of community mental health and prevention in Maine for over 25 years. He currently leads the training and technical assistance efforts of the Maine Suicide Prevention Program, providing suicide prevention, assessment and postvention training and support across the state. Since 2007, Greg has developed and presented training and education supporting the needs of a diverse set of partners in suicide prevention. He comes to this work from a background in crisis and emergency services, substance abuse prevention, and program management. Greg lives in Rockland with his family and spends considerable time messing about with wild and medicinal mushrooms as an author, teacher and forager.

Robert McCarley, MD

Dr. McCarley came to Spring Harbor Hospital and Maine Medical Center from the Harvard Longwood Psychiatry Residency Training Program and Harvard Medical School graduating in 2003. During his residency, Dr. McCarley worked at The Brigham and Women's Hospital, Beth Israel Deaconess Medical Center and Massachusetts Mental Health Center and earned Chief Resident Massachusetts Mental Health Center Day Hospital. Dr. McCarley has a very strong academic background, earning his BA degree with honors from Colby College in Waterville, Maine and his Medical Degree from George Washington University's School of Medicine in Washington DC where he won the Psychiatry Award for the class of 1999. Dr. McCarley was an outpatient attending psychiatrist at MMC. He also functioned as the Partial Hospital Medical Director at the outpatient psychiatry department at Maine Medical Center from 2003 to 2007. He worked closely in education, working with Tufts, UVM and UNE medical students and with the MMC psychiatry residency program. From 2008 to 2013 he served as the Outpatient Psychiatry Residency Director for the 3rd and 4th year residents. In 2013 he transitioned to working inpatient and is currently the Medical Director for Spring Harbor Hospital.



Amber McGowan

Amber McGowan is a Professional School Counselor at Morse High School in Bath, Maine. She is completing her M.Ed. through Liberty University. Amber has worked as a caseworker for Navy-Marine Corps Relief Society for 14 years and has served as Director of NMCRS BNAS. She home schooled four children through 8th grade and has been an active volunteer with Boy Scouts of America, St. Mary's Church, and other youth community organizations.



Michael Mitchell, LCSW

Michael Mitchell is the clinical director of Crisis and Counseling Centers, Inc. in Augusta, Maine. He brings over 26 years of clinical and administrative experience, focusing on intervention and program development in areas of risk assessment, trauma, and criminogenic change. Mr. Mitchell integrates these "real-life" experiences as the foundation for his extensive experience as a presenter and educator in the behavioral health field.



Tara Mitchell, BSW, MHRT CSP

Tara Mitchell has 18 years of social service experience primarily in mental health/co-occurring conditions. She has worked at Crisis and Counseling for the past 14 years as a Crisis Worker, Midnight Team worker (ride along with WPD), Team Leader, and for the past seven years as the Program Manager for Mobile Triage and Outreach services. Crisis and Counseling serves Kennebec and Somerset counties, fielding roughly 2500 phone calls a month while also seeing 350-500 clients face to face. Tara oversees approximately 45 staff, and holds a BSW from the University of Southern Maine. She will earn her MSW in May.

Geoffrey Nappi, LCPC

Geoffrey Nappi is the interim Program Manager for crisis response services through CSI. He is a licensed clinical professional counselor and has worked in the field for over 20 years. Geoff has been with CSI for 19 of those years, and specifically at crisis response for the past 11 years, eight as supervisor.



Betsy Parsons, BA, MAT, CAS

Betsy Parsons taught for 30 years at two public high schools and an independent school in Portland, Maine and was a founding member of GLSEN-Southern Maine (Gay, Lesbian & Straight Education Network, Southern Maine Chapter) in 1996. The Portland Public Schools' first LGBT faculty member to teach fully out to students and families, she volunteered for several years as faculty advisor to Maine's second public school Gay-Straight-Trans Alliance (GSTA), a student-initiated school club to reduce anti-LGBT hate language and harassment in school. Betsy has been helping Maine students organize GSTAs regionally and coordinating the statewide network of GSTAs since 1999. Forty percent of Maine high schools now have an active GSTA: 70 schools in every Maine County but Piscataguis. Gay-Straight-Trans Alliances are often small but have disproportionate power to improve school climate for all. They offer a safe, supportive space at school for youth who are coming out. They also provide leadership training ground for justice-loving young people, LGBTQ and straight together, who want to stand up and take action to protect the safety and educational access of all students. GSTA youth work together as allies across many kinds of differences and help to prevent school violence nationwide. Betsy's professional service in this movement reflects her commitment to youth leadership, equal educational opportunity and nonviolent social change.



Heather J. Perry

Heather Perry is Superintendent of Schools for RSU 3, one of the top-three, geographically largest school units in Maine. RSU 3 serves approximately 1,500 students in rural Waldo County. Previously she has served as the Superintendent of Schools for Union 60 in Greenville, which comprises the 5 towns of Greenville, Shirley, Beaver Cove,


