# **1. Election Process**

In British Youth Council elections we use Single Transferable Vote (STV). Each voting delegate will put numbers next to candidates, with their favourite candidate as number one, their second favourite as number two, and so on. Voters can put numbers next to as many or as few candidates as they like. To get elected, candidates need to reach a set share of the vote, known as the quota, determined by the number of positions to be filled and the number of eligible votes.

Each voter gets just one vote, but the numbering provides instructions for the counters to allow the vote to transfer. Once all the votes are counted, any candidates who have more than the quota are elected. In order to properly represent the view of the electorate, rather than waste votes over the quota, these votes are re-distributed based on the voter's instructions. If no candidate gets elected then the worst performing candidate is eliminated and their votes redistributed. This process continues until all seats are filled.

Along with the candidates, in each election there will be an option to select 'Re Open Nominations (RON)'. 'RON' is a democratic mechanism to allow voters to choose not to elect any of the candidates in the election. If RON wins the election, then nominations will re-open and this will give more people the chance to stand for the position.

You should vote RON if you feel the none of the candidates are up to the job. However if you think that only one candidate is worth your vote, then you may choose to vote RON as your second choice. If there are two candidates that are worth your vote then you may choose to vote RON for the third choice, and so on. You do not have to vote for RON at all if you don't want to.

At the Annual Council meeting we will be electing:

- One Treasurer
- Two trustees on a full three-year term (top two candidates)
- One UK Young Ambassador



# 2. Trustee and Treasurer Elections

Duties of the Trustee Board are defined by Memorandum and Articles of Association, and by the Rule Book of the British Youth Council. The Board is responsible for strategic planning, accountability and measurement of performance of the British Youth Council as a whole. This requires Board members to collectively have a wide range of skills, knowledge and experience.

These areas include:

- Governance;
- Financial knowledge and expertise;
- Fundraising and income generation;
- Developing external partnerships;
- Strategic planning and leadership;
- Advocacy;
- Marketing and brand promotion;
- Knowledge of youth participation;
- Human resource management.

The British Youth Council is particularly seeking a diverse range of Board members (in terms of experience, skills and background) to continue to embed the new governance arrangements and take forward our strategy.

It is important that candidates are able to adopt a UK-wide perspective on issues that will be addressed by the Board, and the ability to step beyond any member organisation that they may have come from. It is also important that Board members do not hold significant posts in Member Organisations or British Youth Council programmes, once appointed, both to ensure that there is no conflict of interest, and also to ensure that they are able to devote the time required to their role.

Nominations for the roles of Treasurer and Trustee were reviewed by a sub-group of the Board of Trustees, and the long-listed candidates were invited to interview. The short list that is being presented to the Annual Council Meeting consists of those candidates who met the minimum requirements, and the sub-group is happy to recommend that any of these candidates become members of the Board.

Two candidates for Treasurer were shortlisted, meeting the minimum standard and experience required to function as the Treasurer of a charity this size. Due to personal circumstances one candidatehas withdrawn from the process, meaning that only one candidate is being presented to ACM.

At the Annual Council Meeting, two new trustees and one Treasurer will be elected by delegates of full member organisations. Trustees will serve for a term of three years and the Treasurer will serve for a term of two years.



# 3. Role of a Trustee

The Board of Trustees are legally responsible for the charity – this is a significant responsibility and one that should not be taken lightly. They have responsibility for ensuring it is well run, is financially secure, and doing the work it is meant to be doing. All those elected to the Board will serve as Trustees, and so will share the Board's responsibilities.

General duties of a Board (Charity Commission):

- Ensure the charity is carrying out its purposes for the public benefit;
- Comply with the charity's governing document and the law;
- Act in the charity's best interests;
- Ensure the charity is accountable;
- Manage the charity's resources responsibly;
- Act with reasonable care and skill.

As well as the legal duties and those detailed in the Charity Commission guidance, the British Youth Council defines the responsibilities of the Board in its rule book and these can be summarised as:

- to set the vision, values and objectives of the organisation;
- to develop the strategic direction of the organisation, sometimes using subcommittee to do this work;
- to act on behalf of the British Youth Council as a decision making body on some policy matters as set in Council Meetings;
- to appoint from its members and from member organisations, representatives as necessary
- to represent the Council to other bodies, and allocate representation opportunities to the most appropriate committees;
- to be responsible for all financial and legal aspects of the organisation, including buildings property and assets of the British Youth Council;
- to promote the British Youth Council to external organisations, and review and develop partnerships;
- to be responsible for the appraisal of their own work;

Trustees act collectively as part of the Board of Trustees. Together, the Board is responsible for all of the points above.

In addition to the role outlined above, the Treasurer has the following responsibilities:

- to chair the Finance Committee;
- to support the Chief Executive and other staff with the financial aspects of their role;
- to communicate financial information to the Board and assist them in understanding this;
- to oversee the production of the annual budget and propose its adoption to the Board;
- to support the board in ensuring proper records are kept and that effective financial procedures and controls are in place;
- to advise on the financial aspects of plans, proposals and feasibility studies;
- to lead on appointing and liaising with the auditors;
- to propose the approval of the audited accounts to a Council Meeting;

# 4. Candidates for Treasurer

## Candidate 1: Tom Clark

My name is Tom Clark. I'm a 22-year-old student and sit on the Board of two charities whilst studying and working part-time in aviation – a varied mix! I want to join the BYC as Treasurer to develop new opportunities – both for the BYC and for young people through the BYC – continuing my focus of increasing inclusion at all levels.



## About Me – My Experience:

I have a varied background, though my main interests are in

politics and the charity sector (although I'm also a keen football and cricket fan). Financially, I have extensive and growing strategic experience of financial management and budgeting through my Trustee Board and Finance Committee membership, and over recent years have seen success in the form of organisational growth and impact maximisation.

## What I want to Achieve:

In and above the fundamental Treasurer responsibilities – namely ensuring financial effectivity / impact and sustainability – these are some key personal priorities:

- Exploring new corporate and individual engagement opportunities to open new doors for income generation and practical opportunities

# 6. Candidates for Trustee

#### Candidate 1: Zara Khan

Hi, I'm Zara, a 21 year old from Walsall. I work at Walsall Council where I support businesses and organisations to have more diverse workforces. My team is part of a pilot integration programme with Central Government. I assess organisation's recruitment and employment practices and advise them on ways to improve. I have organised events, hosted events such as Remembering Srebrenica and Community Iftar dinners and liaised with partners to ensure that projects are completed effectively and efficiently.

I stumbled on my passion for youth voice when I attended my first



Youth of Walsall (YOW) meeting in 2016. During my 2 years as Chair, I represented YOW at various events/panels which has helped me to hone my public speaking and networking skills. Due to limited resources, I suggested that we apply for funding to finance our 'Real Knives, Real Lives' knife awareness campaign which aims to educate young people around the dangers of knife crime. As Chair, I ensured that the money we were successful in applying for was spent responsibly. We were awarded the Police and Crime Commissioner's Community Thank You Award for our campaign!

I'm applying to be a BYC trustee because the charity is run by young people, for young people. I have seen youth issues being discussed without young people and I think BYC's approach is refreshing and logical. I will use my skills from my role, being Chair of YOW and being a Senior CSE Champion for Street Teams, such as partnership/team working, how to manage a budget, and being a great ambassador, to ensure that I am an effective trustee.

I have a keen interest in youth empowerment as evidenced through my work at YOW. Now I want to take my skills, experiences and knowledge and influence positive change on a regional/national level to ensure young people's voices are heard. My experiences as a Member of Youth Parliament, within the Procedures group, as a member of the NHS Youth Forum, as vice-chair of the Youth Select Committee and as a UK Delegate to the Commonwealth Heads



of Government meeting, have allowed me to create positive change on issues like mental health, young people's confidentiality rights and poverty. More recently, I have worked as a Special Support Assistant in a high school where I must make extremely tough decisions about the welfare of some very vulnerable young people experiencing a range of issues.

Young people deserve a voice, and I believe the British Youth Council is an important vehicle in empowering young people to make a positive impact on their communities. As a young person myself and in my job working as a responsible adult for young people with some very complex needs, I have a unique position as an advocate and an activist, and this perspective gives me the responsibility and the passion to make an excellent trustee.

As a trustee I would focus on three key areas:

- Make BYC more accessible to those from challenging backgrounds. Not all young people have access to the internet or the literacy levels to tackle long application forms. I would offer other ways of applying for our programmes.
- 2) Share YOUR successes. BYC members are doing some amazing things and I want this to be celebrated!
- 3) Offer clearer communication between members and trustees. I want to know what is important to YOU so I would ensure you have the opportunity to tell me!

Ultimately, I want to support young people to challenge themselves, help others, experience completely new things and find what they are passionate about.

### Candidate 5: Michael Woodland

Hello! My name is Michael Woodland, and I am a Business Improvement Officer for Barnet Council's homelessness service. I'm originally from Gloucestershire, studied at Cardiff University to achieve a master's degree in politics and public policy, and moved to London a year ago to build a career in the housing sector. Having worked in homelessness and grown up in a working-class family, I have seen the impact of inequality and marginalisation on sections of our society. Nowhere is this starker with young people, whose needs and aspirations can often be side-lined or ignored. Subsequently, I want to help lead the BYC to champion further empowerment and engagement of young people in the pressing issues of the day.



Working for Barnet Council as a Housing and Business Improvement Officer has developed several skills that would allow me to excel in the trustee role. This includes developing my resilience and decision-making ability to help vulnerable people. I also have experience of project management, data analysis and team building from implementing several business improvement initiatives, notably to restructure the department. I am also a passionate campaigner, having been a columnist and strategy advisor for The Young European (TYE) News, a small pro-Remain media outlet. I am also a 2019-2020 Uprising Leadership alumni, having created a campaign to raise awareness of food poverty in Tower Hamlets. This volunteering has given me a professional background in strategic communications, grass-roots campaigning and networking with organisations to champion positive social change. If I were elected a trustee for the BYC, my three main priorities would be to:

- 1) Implement a campaign to raise awareness of youth homelessness and unaffordable rents for young people
- 2) Improve BYC's communication structure to become more responsive to member organisations and enhance visibility to external audiences

3)	Increase training, development and	collaboration opportunities for BYC's member

# 9. Honorary Presidents Election

Each year three MPs, one from each of the largest three parties in the House of Commons, are elected to this position. They champion the British Youth Council's work to other parliamentarians, and try to highlight the British Youth Council's work and your voice to decision makers and the Government.

In the event that 'RON' is elected for any of the Honorary President positions, the decision of who shall fill the vacancy passes to the Board of Trustees. When required to decide upon an Honorary President, the Trustees shall take into account the views expressed by the membership, and candidates who featured in the original election shall be excluded from consideration. The decision of the Board of Trustees is final.

# 10. UK Young Ambassador – European Youth Forum

The UK Young Ambassadors enable young people from across the UK to have a voice and influence in international decision-making and to campaign for change on local, national and international levels. The UK Young Ambassador programme is open to any young person (18-25) from across the UK (England, Northern Ireland, Scotland and Wales). The programme is divided into three main strands:

- Two UK Young Ambassadors representing the British Youth Council and our members in the Commonwealth Youth Forum;
- Two UK Young Ambassadors representing the British Youth Council and our members in the European Youth Forum;
- Four UK Young Ambassadors (one from each of the nations in the UK) leading our work on the EU Youth Dialogue.

The UK Young Ambassadors for the European Youth Forum and the Commonwealth Youth Forum are elected by our member organisations, while the UK Young Ambassadors for the EU Youth Dialogue are selected.

At the Annual Council Meeting we will be electing one male or non-binary UK Young Ambassador to the European Youth Forum. Our intention is to have a gender-balanced delegation, which is why we have only opened this call to young people who identify as male or non-binary. The term of office for the new UK Young Ambassador will be three years.

#### Role of a UK Young Ambassador to the European Youth Forum

- Inform and influence European policy making through attending the European Youth Forum Council of Members Meetings (COMEM) as well as representing the British Youth Council at sub-regional meetings;
- Get involved in research and consultation with young people across the UK to gather their views, including workshops, focus groups and online research, whenever appropriate;
- Design and deliver advocacy actions, responding to UK young people's needs and concerns arising from the European Youth Forum;
- Share information from the European Youth Forum with the Member Organisations of the British Youth Council and with young people across the UK;
- Ensure the most current and pressing issues for young people in the UK are translated in European youth policy making;
- Liaise with the wider team of UK Young Ambassadors to align work and priorities and assist the rest of the team on relevant campaigns and advocacy on local, national and European levels;
- Raise awareness of European campaigns, policies and actions through reports, blogs, websites and social networks;
- Represent UK young people at European events and to UK decision makers;
- Provide policy feedback to the British Youth Council, member organisations and youth and networks;
- Be an active part of a European network, share information, ideas and actions.



The newly elected UK Young Ambassador will be working alongside the existing UK Young Ambassador to the European Youth Forum **Lucia Jones**. Lucia is from Wales recently finished studying Theatre and English at Brunel University London. She used to be a member of Powys Youth Forum and Funky Dragon and was elected to represent Wales at the 9th Commonwealth Youth Parliament in the British Virgin Islands in October 2017. She is currently in her third year representing the British Youth Council at the European Youth Forum.



#### Candidate 1: Rory Daniels

As a 19-year-old Parliamentary Candidate in the last UK General Election, I sought to put the concerns of young people on the agenda. Before the campaign I led a non-partisan drive to register more students to vote, and my manifesto focused exclusively on issues that affect us. These include the scrapping of housing benefits for 18- to 21-year-olds and falling mental health funding. After the election, I decided to utilise the leadership and communication skills I had developed to multiply my impact beyond my constituency. Today, I hold an advisory role at the European Commission (on youth and industrial policy), sit on Amnesty



International's global Youth Task Force board as the UK's representative and lead youth projects across London through my role as a Global Shaper for the World Economic Forum. I also get stuck in on the ground, conducting focus groups across Wales through my work as a Structured Dialogue Champion for the British Youth Council. Importantly, through these positions I have instigated real change. For example, just a few months ago I was recognised by Target Jobs as one of the UK's Top-10 Undergraduates of the Year for Impactful Social Action for my work with refugees and those left-behind by globalisation and technological change. Having recently completed a Political Economy degree at King's College London, reached the final of essay competitions run by the Royal Economic Society and European Commission and spent years working in the UK Parliament (in both the House of Commons and House of Lords), I believe that when confronted with a challenge, my skills lie in consulting stakeholders, establishing an academic grounding for my arguments and then communicating my position with confidence and authority. In this time of great political uncertainty, the British Youth Council is presented with an incredible opportunity to set the Europe-wide agenda on youth affairs and participation. It is my ambition to lead the charge in setting this agenda.

#### Candidate 2: Tom Matthew

Hello! I'm Tom, the MYP for North Devon, West Devon and Torridge. I study Politics, Geography and Sociology at Exeter College; I sit on the board as Student Governor and I am the Under-Secretary General of Exeter College Model United Nations (MUN). I really enjoy debating and I have achieved my Grade 8 in Public Speaking from LAMDA. I love going to talks and lectures; one of the best I've attended was on leadership with Barack Obama! Aside from academic stuff, I play piano and run, cycle and swim. In April, I was one of the youngest runners to finish the London Marathon! I have used running to raise over £5,000 for a charity I volunteer at, Amigos Worldwide. In 2016, I visited Uganda with Amigos: this trip sparked my passion for social justice.



I began to see how the quality of life intrinsic to living in the UK, drastically differs from that experienced by billions of others. Since visiting Uganda, I decided to do everything I can to use relative fortune to better the lives of others. The role of UKYA to the European Youth Forum is an amazing opportunity to do this.

When young people's voices are listened to, society almost objectively improves. I see the principle role of the UKYAs as representing the views of young people thoroughly and meaningfully. This has been a key aim for me as a MYP. I've visited four schools and a youth centre where I discussed topics including the climate crisis, the curriculum and Brexit with young people. These discussions formed the basis for meetings with the two MPs for the two constituencies I represent, one being the Attorney General. I recently spent 45 minutes with him scrutinising his role in the Brexit process- a particular interest for my constituents. I have spoken to the full Devon County Council and with individuals to discuss specific concerns the young people raised.

#### Candidate 3: Rory Moore

I applied to be the young ambassador to the European Youth Forum as I want to ensure that young people's voices are heard in the decisionmaking process on a European level, no matter what happens with Brexit! I recognise the value of young people and their ideas, and have shown consistently throughout a number of roles that I have the necessary skills to be an effective ambassador. For instance, I have given speeches in Parliament and at events in London, showing I am confident at speaking in public. I have also met with important decision-



makers from the Cabinet such as Andrea Leadsom and Chris Grayling, securing a key reform to transport policy (something that was important to young people in my local area). This shows I am able to influence policy by lobbying those in power and representing the interests of those who I am elected to serve. Indeed, I am passionate about representing young people and ensuring they are taken seriously by those with power – as your ambassador, I would engage with young people from all over the UK to ensure their voices were heard in European decision-making.

I also have media experience, having been interviewed on platforms ranging from BBC radio to Turkish TV – I think this would help to project the views of young people and ensure that issues affecting us gain sufficient coverage. Beyond that, as a Parliamentary Ambassador for the BYC, I conducted research into important issues and produced a briefing paper for decision-makers. I also offered insight on policy recommendations at a roundtable, eventually helping to shape the Government's new Civil Society Strategy. This shows that I can deal with complex policy matters.

### Candidate 4: Khalil Richard

I am Khalil Richard and have been passionately representing people since I was sixteen years old. I am visually impaired and grew up in the care system so have learned first-hand the barriers which are faced by people in similar positions, and continue to challenge these for myself and others. This is a source of powerful drive within me to be successful when campaigning and representing constituents. I am incredibly passionate about helping others to overcome barriers they are faced with in society, whatever their circumstances, and wish to help inform and inspire them whilst fighting their corner on the political stage.



In February 2018, I joined the Sheffield Youth Cabinet and was chosen to take over from the leaving representative for young people in care/care leavers. After finishing the remainder of the term, I was re-elected as secretary for transport and children in care/care leavers. When in this role, I campaigned for more accessible public transport in the North which will introduce audio voiceovers in all transport by 2021, I have helped develop the South Yorkshire Transport Charter, and am actively challenging the environmental impact of Sheffield City Region's public transport.

Whilst I was in the care system, I started attending the Children In Care Council in September 2016. Here, I campaigned on a variety of issues that young people in care face, such as fairer financial distribution by designing an entitlement strategy guideline to provide direction on the fair share of pocket-money and personal expenses.

In 2016, the Sheffield Care Leavers Union (SCLU) was formed. Here, I worked on many different projects, for example campaigning on council tax exemption for care leavers, to help them become financially independent sooner. As a member of SCLU, I advocate for care leavers in a wide range of projects, and also became a member of Coram Voice as an ambassador for children in care/care leavers. This means I now represent all children in care/care leavers in Sheffield and attend monthly conferences in London, adding further gravitas and a wider audience to elicit greater support for those I represent.
