## **DRUG RECOGNITION**

This full-day training will teach you how to skillfully recognize and properly evaluate a person under the influence of drugs, understand the 7 step administration of the Drug Recognition Process, use the pupilometers and pen lights, understand drug physiology and pharmacology. This course will help you understand drug identification techniques and methods of use, recognition of drug signs and symptoms, drug paraphernalia, dangers of confronting subjects under the influence, and legal issues. You will understand the requirements for organizing and presenting testimonial and documentary evidence in 'under the influence' cases and how drugs impair one's ability to operate a vehicle. You will gain an in depth understanding of the 8 categories of drugs, and their signs and symptoms.

## **MARIJUANA INVESTIGATION**

Taught by experienced and respected DRE Instructors, you will learn how to complete an investigation in which the person may be impaired by cannabis. Although we would want a DRE doing this investigation, it is not always feasible to have one at the scene of every marijuana DUI—there are just too many. We developed this course so that officers can use their existing training along with other observations to help them conduct a better investigation.

## **NARCOTIC SAFETY**

One of the most dangerous aspects of calls involving drugs is dealing with unknowns. Over the last decade the proliferation manufacturing and distribution of synthetic drugs has created extreme hazards for first responders, officers and home health care workers. If you cannot "recognize a hazard, you can't protect yourself". This training is designed for all public safety and health professionals who come in contact with subjects, enter residences (i.e. search warrants, probation checks, medical and fire calls) or conduct investigations. This course will also address specific hazards associated with manufacturing controlled substances (i.e. fentanyl, counterfeit tablets). This course primarily addresses officer and home health care professional safety and hazard assessment.
