

# Barry Burton

## BIOGRAPHY

---

Barry J. Burton, D.O., P.H.P. is a residency trained, Board Certified Emergency Physician with sub-specialty Certificate of Added Qualification (CAQ) in Emergency Medical Services currently serving as a Visiting Assistant Professor in the Disaster Medicine and Management graduate program of Jefferson (Philadelphia University + Thomas Jefferson University) East Falls, Philadelphia.

Dr. Burton began his career in 1975 as an EMT-A, obtaining his B.S.N. from Temple University in 1980, served as a Paramedic Instructor for the Philadelphia Fire Department EMS. He completed medical school in 1988 at the Philadelphia College of Osteopathic Medicine (PCOM) in 1988, and the Emergency Medicine Residency at Albert Einstein Medical Center, Philadelphia & PCOM in 1992. Dr. Burton continued as clinical teaching faculty at Einstein, a Level I trauma center with a high percentage of assault related trauma experience, often managed initially by the Emergency Department staff.

Barry's service with a suburban Philadelphia Advanced Life Support Emergency Medical Service (EMS) provider permitted the opportunity to serve as the Tactical EMS Medical Director, to support several warrant service operations, and to consult pro bono with the Bucks County Police Major Incident Response Team, providing significant volunteer hours of education to the South Eastern Pennsylvania Terrorism Task Force members through the Philadelphia Police Department Counter Terrorism Operations Unit. In this capacity he facilitated the modification of the published Tactical Combat Casualty Care (TCCC) and Tactical Emergency Casualty Care guidelines for promulgation among the ranks of the Philadelphia Police Department concomitant with the issuance of a tourniquet and bleeding control kit to every officer. He has spoken at the International Association of Chiefs of Police (IACP) convention in Philadelphia, sharing the stage in discussion of project implementation. Dr. Burton firmly supports the Hartford Consensus Statements on Bleeding Control, as well as immediate Life Saving Interventions, and the widespread training of all inhabitants, America's First Care Providers.

One final note: Barry J. Burton maintains an instructor Training Counselor position for all civilian programs with the National Rifle Association, and had Law Enforcement division instructor certification for Pistol and Shotgun through that organization.
