# **Terms and Conditions**

# Cozy Convos™ | Chase Legacies™ is the 501 c(3) entity under which Cozy Convos™ is located

(Collectively referred to as Cozy Convos, we, our, us)

**Cozy Convos™**, recognizes the importance of keeping all our attendees informed about all terms and conditions relating to our Fall 2015 retreat. When you register yourself, you agree to abide by all of our terms and conditions stated below. By registering for our Fall 2016 retreat, you agree to be bound by our Privacy Policy.

# **Your Personal Information**

When you register for our Fall 2016 retreat, you are providing us with your personal information, which includes your address and your contact details. We collect your personal information in accordance with our privacy policy.

# **Our Privacy Policy**

Your privacy is important to us.

We collect and store your email address and any other information including address, phone number, organization affiliation, photo, etc., that you provide. However, this information is only used for communications and marketing of **Cozy Convos™**, and **Chase Legacies™** events and is available to **Cozy Convos™**, team members only. We do not share or sell our contact list or any other information with third parties.

#### **Registration Fees**

- Early Bird Fee is \$215. Nonrefundable Deposit of \$50 must be made by Aug 4th
- Regular Fee is \$250 Nonrefundable Deposit must be made between Aug 4-Sept 28th
- Payment plan options- Deposit must be made by Aug 29<sup>th</sup>, First payment will be due by Sept 22nd and Second and final payment by Oct 12th

#### **General Refunds**

Full Refund: If the notification of cancellation is communicated by Oct 1 that a registered person for whatever reason, cannot attend the retreat, the individual will receive a full refund (minus the \$50 refund) Partial Refund: If the notification of cancellation is communicated between Oct 2- Oct 10 that a registered person cannot attend, for whatever reason, the individual will receive a partial refund of 50% (minus the \$50 refund). After Oct 10<sup>th</sup>, no refunds will be granted

#### **Transferring Tickets**

Registration is transferable. Must be communicated to **Cozy Convos™** by Oct. 25th

#### **Payment Plan**

Payments are due by the designated deadlines. If payments are not made by the agreed upon deadline, there is a chance that you will forfeit your spot and receive a refund only if there is a waiting list. We suggest communicating with **Cozy Convos™** should there be a problem making payments on time.

#### **Medical Treatment Consent**

By attending the retreat, you give permission for the Camp of the Hills staff (camp site), our staff, volunteers and leaders to obtain emergency medical, hospital or ambulance assistance (referred to as "assistance") to you at any time when considered necessary. Our insurances prevent us from directly administering medical treatment to you. You agree that you are responsible for all costs and expenses incurred in obtaining assistance for you or to your children.

# **Assumption of Risk**

# From Camp of the Hills Waiver and Liability Form

There are numerous obvious and non-obvious inherent risks always present in spending time on a campsite in a rugged environment despite all safety precautions. Related injuries can be severe requiring hospital care and resulting in more lasting residual effects than activities in a safer or indoor environment.

Please know that Camp of the Hills is the location for a summer youth camp and other retreats year round.

*Wildlife* – Being a Campsite – the camp might be inhabited by wild animals such as mammals, reptiles, and insects, which are not tame, may be dangerous, and unpredictable in nature. These wild animals will be wandering at their will. There are potential consequences such as being bitten.

**Activities** – Depending on your groups choice of activities, such campsite activities can be dangerous, such as camping, swimming, hiking/nature walks, cooking, and sports. The consequences of these risks could include drowning, falling, getting a concussion, needing stiches, broken bones, or other types of injury or death. The two categories mentioned above and their enumerated consequences are certainly not all inclusive, but mere examples while on the premises.

# Indemnity, Release and Risk Waiver

#### Waiver of Liability

We do hereby agree to indemnify and hold Cozy **Cozy Convos™** and Chase Legacies, and its agents, servants, and/or employees, harmless from any and all damages, claims, expenses, or costs of whatever nature, causes of action, suits, and liability of any kind including attorney fees, court fees, investigative fees, or other types of legal fees for any cause of action to include, but not limited to, theft, injury, or death of any person in our group's use and/or occupancy of the premises or participation in camp programs and facilities. The signer indemnifies against the claims made by the signer, spouse, parents, heirs, administrators, and assigns. Further, this agreement is a Covenant not to sue any parties listed herein.

This waiver applies to all persons attending the Cozy Convos Retreat and remains in effect until the evening of Sunday Nov 6.
